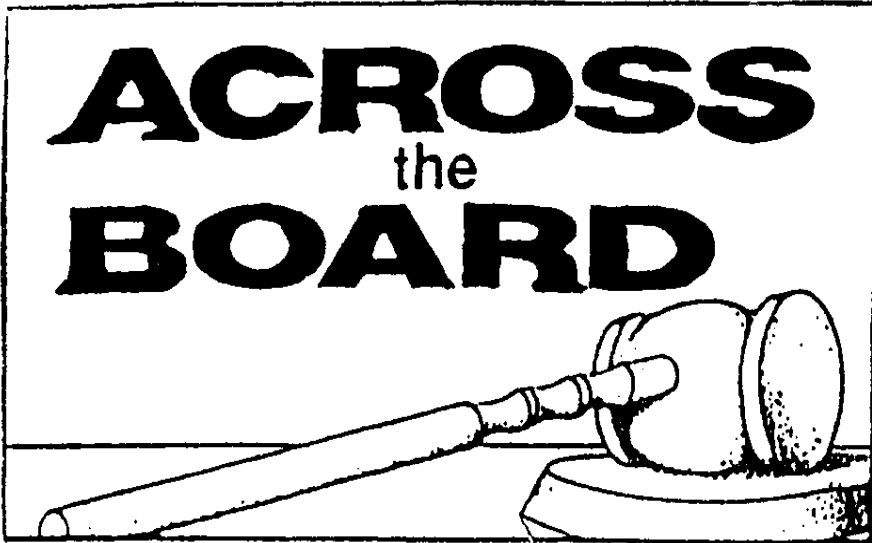

The Board approved:
