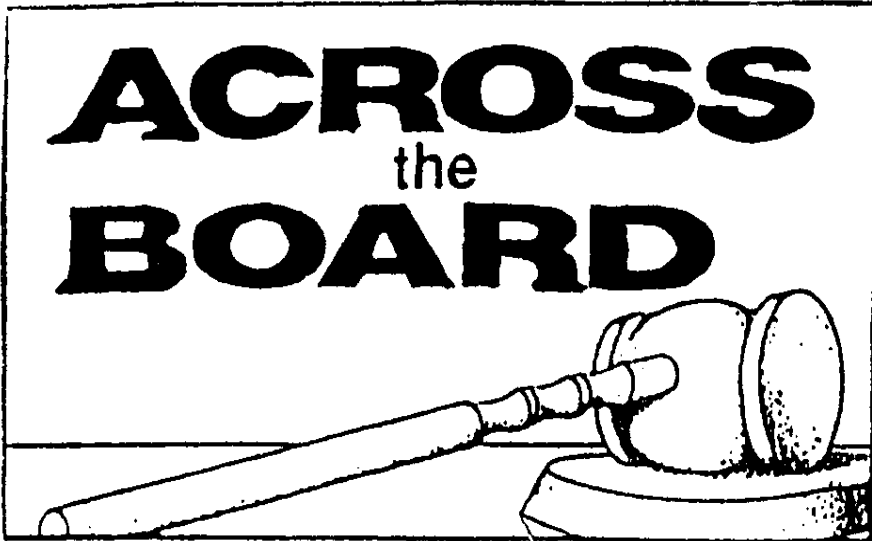

The following revised and updated protocols for Face Covering in the District's Plan for Safe Return to In-Person Instruction, effective March 7, 2022: Based on the Governor's Executive Order regarding the wearing of masks/face coverings in schools being rescinded, the wearing of masks/face coverings in the schools of the Lower Cape May Regional School District by staff, students, and visitors, will not be mandated but will be optional. The exception to this rule is that masks will be required to be worn by

staff and students on school busses as per Federal mandate until such mandate expires or is rescinded.
