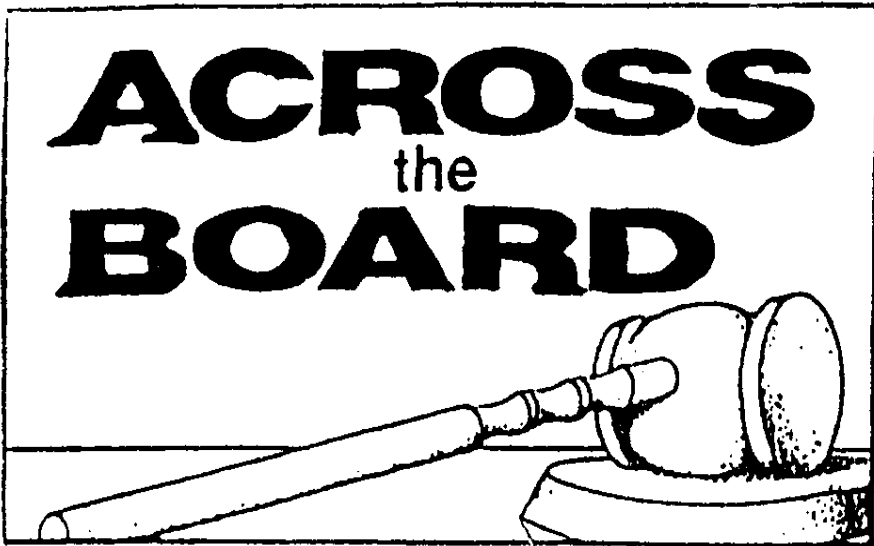

The resolution of the Lower Cape May Regional School District Board of Education, making certain determinations in connection with the proposed building program, to undertake certain Capital Improvements including HVAC and Electrical System improvements at the LCMR High School and RMT Middle School.

The resolution of the Lower Cape May Regional School District Board of Education, approving the submission of a proposal to the voters of the School District at a Special Election to be held on Tuesday, January 25, 2022 to undertake \$13.9 million in Capital Improvements, including HVAC and Electrical System improvements at the LCMR High School and RMT Middle School and a new roof at the RMT Middle School.

The substitute teacher rates to be \$125/day for Certified Substitute Teachers and \$120/day for Non-Certified Substitute Teachers, effective October 1, 2021.

Referral incentive – if any staff member refers a new driver to the district, he/she will get a \$150 referral bonus after the driver has been with the District for six months.

Hiring bonus – If a new driver is hired by the District, he/she will receive a \$750 hiring bonus after the driver has been with the District for six months.
