**WHEREAS**, Garrison Architects approves Change Order #6 for the total amount of \$23,957; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Education of the Lower Cape May Regional School District, that Change Order #6 totaling \$23,957, for a revised total contract of \$1,285,466, is hereby approved at the Board of Education meeting held on this 26<sup>h</sup> day of April, 2023 (Addendum FIN C).
