I also understand that I am fully responsible to pay for any repairs, damage, or loss of the Chromebook. I have read the LCMRSD 1:1 Chromebook Initiative Student Guidelines, and I understand that any violation of the guidelines in the packet can result in discipline consequences subject to the judgment of the Assistant Principal and/or Principal.

- ✓ *Chromebooks that are found to be damaged due to misuse, deliberate damage, or neglect may result in a fine being issued to the students/parents of the responsible parties.*
  - ✓ *In the event of theft, vandalism, or other criminal acts, a police report MUST be filed by the student or parent within 24 hours.*
  - ✓ *Each student is issued a Chromebook and a charger that must be returned at the end of the school year. Failure to return each of these items may also result in a fine if proper police reports have not been filed.*
- ✓ *Chromebooks are required to be in class, charged and ready for use every day.*
